In exchange for the Eastern Surfing Association's accepting my entry form, I voluntarily agree to assume all risks incident to the sport of surfing, I fully understand and comprehend the dangers of surfing created by the sharp edges and fins along with the natural buoyancy of a surfboard when they are acted upon by the powerful forces of the ocean and ocean waves. With full knowledge, comprehension and understanding of these dangers, I voluntarily accept and assume all risks involved in the spirit of competitive surfing. I will further read and comply with all the ESA rules and regulations noting existing weather conditions, and do agree that I voluntarily assume all risks arising from conditions related to use of the contest site by myself and others.
